Education and culture are essential to develop a more inclusive, cohesive and competitive Europe. Higher Education and its links with research and innovation play a crucial role in individual and societal development; in providing the highly skilled human capital and engaged citizens that Europe needs to create jobs, economic growth, and prosperity; as well as engagement within the communities, and the rejection of any form of discrimination, active promotion of equal opportunities, greener societies and sustainable development.

Sustained and substantive investment is required in order to turn education into a driver of cultural and sustainable economic development. While authorities in Member States remain responsible for the way Higher Education is organised and delivered in their countries, EU activities are designed to bring an additional international dimension to studying, teaching, researching or policy making in Higher Education.

From this point of view, the effectiveness and efficiency of Higher Education relate, in part, to the availability of funding and the promotion of a culture of quality. Higher Education requires adequate funding, and, as an investment in economic and cultural growth, public spending in this sector should be protected.

Learning mobility is an opportunity for students to develop valuable skills and to expand their horizons by going abroad to study or undertake training. The benefits of mobility are widely recognised. Going abroad to study or to train helps people to develop their professional, social and intercultural skills, as well as enhancing their employability.

In this regard, through its Erasmus+ Programme, the European Union supports international exchanges for students and academic staff, as well as structured cooperation between HEIs and public authorities in different countries.

The University of Salento considers continuous advancement of education and training to be of profound importance. Widespread access to quality education and training is a driver of economic growth, social cohesion, research and innovation - and dramatically increases citizens' prospects for personal development.

The objective of participation in Erasmus+ is to create new opportunities for people in Higher Education to learn from one another across national borders and to work together on joint projects in order to develop better learning and teaching, undertake excellent cooperation and promote innovation. In this context the Erasmus+ Programme provides direct support to people wishing to study or train abroad and to projects fostering cross-border cooperation between HEIs.

The commitment of the University to internationalisation is further demonstrated by the third article of the University of Salento's Statute which declares that: "The University [of Salento] considers the internationalization of its research and teaching as a strategic goal in its development and an enhancement model in its role within the relations with other countries". - recognises the importance of, and provides visibility to, the results achieved by their staff members engaged in individual mobility or in collaborative projects with strategic partners;

- takes into account the results of internal monitoring of European and international mobility and collaborative activities to date, thus further improving its international performance

Thanks to the participation in the Erasmus+ 2014-2020 Programme, the University of Salento has been able already to undergo a profound transformation as a whole. This process has been involving many actors - both internal and external to the University - and has had a strong impact at all levels (institutional, local, national and international).

The participation in the new Erasmus+ Programme is perceived by the University of Salento as a unique and strategic opportunity for realizing a very important follow-up of what has been achieved so far and we expect a significant and steady increase in the growth of our international dimension, in the mobility of our students and staff as well as in an greater involvement in cooperation projects.

At the end of the new period the University of Salento, along with all the stakeholders involved, will have reached a better level of awareness and competence in all its different components: governance (governing bodies, policy makers and decision makers), staff (academic and administrative members), students, partners and stakeholders.

A number of specific qualitative and quantitative indicators will be used for the measurement and the monitoring of the above impact and embedded as a subset within the institutional performance monitoring system, already mandatorily, adopted as fulfilment of national governance regulations for Italian public institutions. Examples of indicators are: (a) submitted/financed mobility/cooperation projects; (b) submitted/financed policy reform projects; (c) outgoing/incoming students; (d) total volume of credits earned abroad; (e) total volume of credits earned by incoming students; (f) outgoing/incoming academic/administrative staff members; (g) total funding/co-funding amounts received

by the EU; (h) level of satisfaction of involved actors.

In order to ensure a sustainable management of all activities, dynamically targets will be tuned and indicators defined on the basis of the actual operational capacity of our organizational structure (general management, including internal management structure, human resources).
